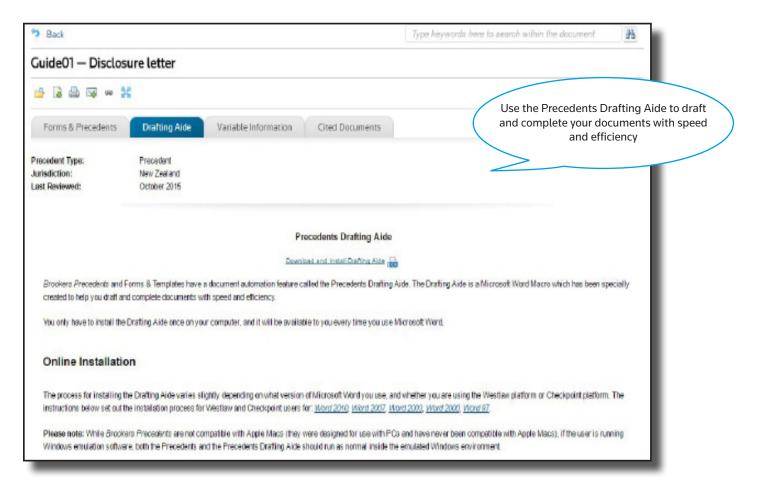

	Tasks You will need to:     obtain the necessary information on which to advise the client (see item GuideO1 — Disclosure letter):
	note that once initial disclosure has been received, this triggers a presumption that the client will be in a position to enter a plea or (if relevant) elect a jury trial at the next court appearance;     note it is unusual for a plea decision to be made on the sole basis of initial disclosure;     be aware that the summary of facts may well be inaccurate at the time initial disclosure is made;     resist the practice of taking instructions from the client based on the summary of facts alone;     remember that request disclosure under s 12(2) of the Criminal Disclosure Act 2008 is a must in all but minor matters.
